

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2017-21**

A Resolution confirming the award by the Summit and Medina Workforce Area Council of Governments of a professional service contract with Education Data Systems, Inc., to provide Workforce Innovation and Opportunity Act Career Services at the OhioMeansJobs Medina County Center, in not-to-exceed amount of \$360,000.00 for the period of July 1, 2017 through September 30, 2018.

WHEREAS, the Medina County Board of Commissioners (the “Commissioners”) adopted a resolution on June 9, 2015 which confirmed an award of a professional service contract with Education Data Systems, Inc. (“EDSI”) to provide Workforce Innovation and Opportunity Act (“WIOA”) Career services to adults and dislocated workers at the OhioMeansJobs Medina County Center (OMJMC) for the period July 1, 2015 through June 30, 2016, with one option to renew for an additional contract term of one year;

WHEREAS, the Commissioners adopted a resolution on July 12, 2016 to renew its contract with EDSI, for the period of July 1, 2016 through June 30, 2017, in the not-to-exceed amount of \$360,000.00;

WHEREAS, the current professional service contract between Medina County and EDSI expires June 30, 2017;

WHEREAS, upon its formation, the Summit and Medina Workforce Area Council of Governments and its Board (“SAMWA COG”) assumed the responsibility of procuring and contracting WIOA professional service contracts in Ohio Local Workforce Area 2 (“Area 2”), comprised of Medina and Summit Counties, from the respective Counties;

WHEREAS, at its regular May 24, 2017 meeting, the Summit/Medina Workforce Development Board (“WDB”) recommended the award by the SAMWA COG of a professional service contract to EDSI to provide WIOA Career Services at OMJMC for the period of July 1, 2017 through ~~June 30, 2018~~; and

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and accepting the WDB’s recommendation, that it is necessary and in the best interest of Area 2 to confirm the award of a renewal contract with EDSI, upon the aforementioned terms;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

SECTION 1

The award by the SAMWA COG of a professional service contract with EDSI to provide WIOA Career Services to adults and dislocated workers at the OMJMC for the period of July 1, 2017 through September 30, 2018, in a not-to-exceed amount of \$360,000.00, as recommended by the WDB at its regular May 24, 2017 meeting.

SECTION 2

This Directive shall take effect immediately upon its adoption.
