

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS  
FOR OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2017-23**

**A Resolution confirming the award by the Summit and Medina Workforce Area Council of Governments of a professional service contract with the United Labor Agency to provide Workforce Innovation and Opportunity Act Career Services at the OhioMeansJobs Summit County Center, in a not-to-exceed amount of \$1,025,000.00, for the period of July 1, 2017 through September 30, 2018.**

**WHEREAS**, the Summit County Council (the "County Council") previously adopted Resolutions No. 2014-281, 2015-125 and 2016-249, which authorized the Summit County Executive to execute a professional service contract, in the not-to-exceed amount of \$963,318.00 annually, with the United Labor Agency ("ULA") to provide employment services for adults and dislocated workers at the OhioMeansJobs Summit County Center (the "OMJSC") for the periods of July 1, 2014 through June 30, 2015, July 1, 2015 through June 30, 2016, and July 1, 2016 through June 30, 2017, respectively;

**WHEREAS**, the current professional service contract between Summit County and ULA expires June 30, 2017;

**WHEREAS**, upon its formation, the Summit and Medina Workforce Area Council of Governments and its Board ("SAMWA COG") assumed the responsibility of procuring and contracting Workforce Innovation and Opportunity Act ("WIOA") professional service contracts in Ohio Local Workforce Area 2 ("Area 2");

**WHEREAS**, at its regular May 24, 2017 meeting, the Summit/Medina Workforce Development Board ("WDB") recommended the award by the SAMWA COG of a professional service contract with ULA to provide WIOA Career Services to adults and dislocated workers, and to provide Business Services to local companies, at OMJSC for the period of July 1, 2017 through ~~June 30, 2018~~; and

**WHEREAS**, the SAMWA COG finds and determines, after reviewing all pertinent information and accepting the WDB's recommendation, that it is necessary and in the best interest of Area 2 to confirm the award of a contract with ULA, upon the aforementioned terms;

**NOW, THEREFORE, BE IT RESOLVED**, by the SAMWA COG that:

**SECTION 1**

The award by the SAMWA COG of a professional service contract with United Labor Agency to provide Workforce Innovation and Opportunity Act Career Services to adults and dislocated workers, and to provide Business Services to local companies, at the OMJSC, for the period of July 1, 2017 through September 30, 2018, in a not to exceed amount of \$1,025,000.00, as recommended by the Summit/Medina Workforce Development Board at their Regular May 24, 2017 meeting.

**SECTION 2**

This Directive shall take effect immediately upon its adoption.
