

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2017-39**

A Resolution amending: Section F, entitled “Procurement Methods,” of the Summit and Medina Workforce Area Council of Governments’ Acquisition and Procurement Policies for Ohio Local Workforce Area 2 in order to align Area 2’s purchasing thresholds with the Uniform Grant Guidance provided through the Code of Federal Regulations, specifically 2 CFR 200, commonly referred to as the “Super Circular”.

WHEREAS, at its meeting held 3/7/2017, the Summit and Medina Workforce Area Council of Governments (the “SAMWA COG”) Board adopted Resolution 2017-07 to adopt the Acquisition and Procurement Policies (the “Policies”) for Ohio Local Workforce Area 2 (the “Area 2”);

WHEREAS, upon further review of Section F of the Policies, it was determined that the thresholds adopted for Micro-purchasing, Small Purchases, and Competitive Sealed Bids (the “Purchase Thresholds”) did not align with the same thresholds in the Code of Federal Regulations (the “CFR”), specifically 2 CFR 200.320; and

WHEREAS, the SAMWA COG finds and determines, after review of all pertinent information, that it is necessary and in the best interest of Area 2 to amend the Purchase Thresholds identified in the Policies in order to align the Policies’ Purchase Thresholds with the same thresholds found in 2 CFR 200.320;

NOW, THEREFORE, BE IT ORDAINED by the SAMWA COG, that:

SECTION 1

The threshold in Section F, Paragraph 1 of the Acquisition and Procurement Policies, “Micro-purchase procedure,” is hereby amended from “\$3,500.00 or less” to incorporate the micro-purchases threshold, as referenced in 2 CFR 200.320, of “allowable for purchases of \$0.01 up to, but not in excess of \$3,000.00.”

SECTION 2

The threshold in Section F, Paragraph 2 of the Acquisition and Procurement Policies, “Small Purchases procedure,” is hereby amended from “\$3,501.00 to \$25,000.00 range” to incorporate the small purchase threshold, as referenced in 2 CFR 200.320, of “allowable for purchases of \$0.01 - \$3,000.00 and required for purchases of \$3,001.00 to \$150,000.00.”

SECTION 3

The threshold in Section F, Paragraph 5 of the Acquisition and Procurement Policies, “Competitive Sealed Bids,” is hereby amended from “over \$25,000.00” to incorporate the Large Purchase Competitive Proposals threshold, as referenced in 2 CFR 200.320, of “allowable for purchases of \$0.01 - \$150,000.00 and required for purchases of \$150,001.00 and above.”

SECTION 4

These amendments shall take effect immediately upon adoption of this Resolution.
