

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR  
OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2018-18**

**A Resolution authorizing the Summit and Medina Workforce Area Council of Government to include Portage Lakes Career Center and the Management & Training Corporation as “Additional Partners,” as defined in the Section 121(b)(2) of the Workforce Innovation and Opportunity Act of 2014, to Ohio Local Workforce Area 2’s State Fiscal Years 2018/2019 One-Stop Operator Memorandum of Understanding at the OhioMeansJobs Summit County Center.**

**WHEREAS**, the Workforce Innovation and Opportunity Act of 2014 (the “WIOA”) requires the presence of partners providing certain services identified in WIOA Section 121(b)(1) at all American Job Centers (the “AJC”) nationally;

**WHEREAS**; WIOA Section 121(b)(2) allows entities not identified in Section 121(b)(1) to be included as “Additional Partners” to a Local Workforce Area’s Memorandum of Understanding (the “MOU”), so long as their inclusion is consistent with WIOA’s goals and receives the approval of the Local Workforce Area’s Workforce Development Board and chief elected officials;

**WHEREAS**, at their meeting held 5/30/2018, and following a review of the services provided by the Management & Training Corporation (the “MTC”), the federal awardee of the US Department of Labor’s Job Corps funds, and the Portage Lakes Career Center (the “PLCC”), a local post-secondary career and technical education provider, the Summit/Medina Workforce Development Board’s (the “WDB”) Executive Committee recommended the inclusion of the MTC and the PLCC as “Additional Partners” to the Area 2 State Fiscal Years (the “SFY”) 2018 and 2019 Memorandum of Understanding the “MOU”), held between Area 2’s AJC Partners, and further recommended their presence at the OhioMeansJobs Summit County (the “OMJSC”) center, and;

**WHEREAS**, the SAMWA COG finds and determines, after reviewing all pertinent information and upon acceptance the WDB Executive Committee’s recommendation, that it is necessary and in the best interest of Area 2 to authorize the inclusion of the MTC and the PLCC to SFYs 2018 and 2019 Area 2 MOU as “Additional Partners” at the OMJSC Center;

**NOW, THEREFORE, BE IT RESOLVED**, by the SAMWA COG that:

**SECTION 1**

The Management & Training Corporation and the Portage Lakes Career Center are hereby authorized to serve as “Additional Partners” to Ohio Local Workforce Area 2’s American Job Center Partner Memorandum of Understanding in State Fiscal Years 2018 and 2019, and are further authorized to provide services, consistent with WIOA Section 121(b)(2)(B), at the OhioMeansJobs Summit County Center.

**SECTION 2**

This Directive shall take effect immediately upon its adoption.
