

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS
FOR OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2018-23**

A Resolution confirming the award by the Summit and Medina Workforce Area Council of Governments of a One-Stop Operator Services contract to the United Labor Agency for the purpose of providing said services at the OhioMeansJobs Medina County Center, for the period beginning 10/1/2018 and ending 9/30/2019, with the option to renew said contract for two additional 12-month terms, in an amount not to exceed \$25,000.00 of One-Stop Center Memorandum of Understanding partner funds.

WHEREAS, the U.S. Department of Labor's Employment and Training Administration funds a network of American Job Centers ("AJCs") to provide free employment assistance to job seekers at AJC network locations across the United States;

WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act of 2014 (the "WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure the Operators of AJCs;

WHEREAS, pursuant to requirements of the WIOA and on the behalf of the Summit/Medina Workforce Development Board (the "WDB"), Ohio Workforce Area 2 (the "Area 2") staff completed a competitive process to procure the Operator for the Area's AJC, known in the State of Ohio as the OhioMeansJobs (OMJ) Center in Medina County (the "OMJMC");

WHEREAS, based upon their evaluation of all submitted bids, the WDB's Performance Committee recommended at its 9/24/2018 meeting that the Area 2 WDB recommend the award of a contract by the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG") to the United Labor Agency (the "ULA");

WHEREAS, the Area 2 WDB recommended at its 9/26/2018 meeting that the SAMWA COG award a contract to the ULA for the purpose of operating the OMJMC Center;

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information and accepting the Area 2 WDB's recommendation, that it is necessary and in the best interest of Area 2 to confirm the award of a contract to the ULA for the purpose of operating the OMJMC Center;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

SECTION 1

The Summit and Medina Workforce Area Council of Governments hereby awards a contract to The United Labor Agency for the purpose of operating the American Job Center located in Medina County, Ohio, known as the OhioMeansJobs Medina County Center, for the period beginning on 10/1/2018 and ending on 9/30/2019, with the option to renew said contract for two additional 12-month terms, in an amount not to exceed \$25,000.00 of One-Stop Center Memorandum of Understanding partner funds.

SECTION 2

This Directive shall take effect immediately upon its adoption.
