

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR
OHIO LOCAL WORKFORCE AREA 2
RESOLUTION 2019-01**

A Resolution approving and authorizing a salary adjustment for employee Christine Marshall, the Executive Director of the Summit and Medina Workforce Area Council of Governments, effective February 4, 2019, the fourth payroll period of calendar year 2019.

WHEREAS, pursuant to Section 3.2(e) of the of the Intergovernmental Agreement for the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG"), the SAMWA COG is the employer of the individuals responsible for assisting the SAMWA COG and the Workforce Development Board to execute their roles as mandated by the Workforce Innovation and Opportunity Act of 2014, for Ohio Local Workforce Area 2 (the "Area 2"), which includes Summit and Medina Counties;

WHEREAS, on March 6, 2017, the SAMWA COG adopted Resolution 2017-06, hiring Ms. Christine Marshall as the Executive Director of the SAMWA COG;

WHEREAS, pursuant to Section 3.2(e) of the Intergovernmental Agreement and the employment agreement between the SAMWA COG and Ms. Marshall, the SAMWA COG Board wishes to grant a salary adjustment to Ms. Marshall, effective February 4, 2019, as a result of work completed as Executive Director during the period since December 25, 2017; and

WHEREAS, the SAMWA COG finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of Area 2 to approve and authorize the SAMWA COG Fiscal Agent, and the County of Summit Payroll Department under the Fiscal Officer, to make the aforementioned salary adjustment for Ms. Marshall, effective for February 4, 2019;

NOW, THEREFORE, BE IT RESOLVED, by the SAMWA COG that:

SECTION 1

The SAMWA COG hereby determines that it is necessary for the effective and continued operation of the public workforce system in Ohio Local Workforce Area 2 to approve the following salary adjustment and to authorize the SAMWA COG Fiscal Agent's office, and the County of Summit Payroll Department under the Fiscal Officer, to make the following salary adjustment, effective February 4, 2019:
