

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS FOR  
OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2019-08**

**A Resolution confirming the award by the Summit/Medina Workforce Development Board of a contractor agreement renewal (second of two) with the County of Summit Department of Job & Family Services to operate Ohio Local Workforce Area 2's comprehensive One-Stop Center, the OhioMeansJobs Summit County Center, in an amount not to exceed \$228,667.53, for the period of 7/1/2019 to 6/30/2020.**

**WHEREAS**, the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG"), at its meeting held August 10, 2017, adopted Resolution 2017-30, which confirmed the Summit/Medina Workforce Development Board's (the "WDB") award of a contractor agreement to the County of Summit Department of Job & Family Services (the "SCDJFS") to operate Ohio Local Workforce Area 2's (the "Area 2") comprehensive One-Stop Center (the "OSC"), the OhioMeansJobs Summit County (the "OMJSC") Center, in an amount not to exceed \$209,183.75 of OSC Memorandum of Understanding (the "MOU") Partner funds, for the period of 7/1/2017 through 6/30/2018, with the option to renew said contract for two additional 12-month terms; and

**WHEREAS**, at its meeting held 7/2/2018, the SAMWA COG adopted resolution 2018-15 awarding a contractor agreement renewal (first of two) to the SCDJFS, to operate the OMJSC Center during the period of 7/1/2018 to 6/30/2019, in an amount not to exceed \$219,569.19 of OSC MOU Partner funds, and;

**WHEREAS**, the SAMWA COG finds and determines that it is necessary and in the best interest of Area 2 to confirm the award of the available second renewal to the SCDJFS during the period of 7/1/2019 to 6/30/2020, in an amount not to exceed \$228,667.53 of OSC MOU Partner funds;

**NOW, THEREFORE, BE IT RESOLVED**, by the SAMWA COG that:

**SECTION 1**

The Summit and Medina Workforce Area Council of Governments hereby awards a contractor agreement renewal (second of two) to The County of Summit Department of Job & Family Services to operate Area 2's comprehensive One-Stop Center (the "OSC"), the OhioMeansJobs Summit County Center, in an amount not to exceed \$228,667.53 of OSC Memorandum of Understanding Partner funds, for the period of 7/1/2019 to 6/30/2020.

**SECTION 2**

This Directive shall take effect on July 1, 2019.
