

**THE SUMMIT AND MEDINA WORKFORCE AREA COUNCIL OF GOVERNMENTS  
FOR OHIO LOCAL WORKFORCE AREA 2  
RESOLUTION 2019-17**

**A Resolution increasing appropriations to Workforce Area 2's WIOA Administrative funds in the amount of \$250,000.00 for various obligations and expenditure activities as recommended by the Summit and Medina Workforce Development Board at their regular meeting held on June 27, 2019.**

**WHEREAS**, Ohio Local Workforce Area 2 (the "Area 2"), created under the Workforce Innovation and Opportunity Act of 2014 (the "WIOA"), administers the public workforce development system in Summit and Medina Counties as governed by the Summit and Medina Workforce Area Council of Governments (the "SAMWA COG"), through its intergovernmental agreement dated November 1, 2016, between the chief elected officials of the Counties, which addresses the logistics of Area 2's functions and fiscal responsibilities; and

**WHEREAS**, Area 2's Fiscal Agent, the County of Summit Department of Finance and Budget (the "CSDFB"), has determined a need to increase the appropriation available of WIOA Administrative funds for various obligations and expenditure activities originally appropriated under SAMWA COG Resolution 2018-25 for operations; and

**WHEREAS**, the SAMWA COG Board finds and determines that it is necessary and in the best interest of Area 2 to appropriate an increase of the aforementioned funds;

**NOW, THEREFORE, BE IT RESOLVED**, by the SAMWA COG, that:

**SECTION 1**

The SAMWA COG hereby establishes increased Calendar Year 2019 appropriations for Area 2's Administrative funds as follows:

This Directive shall take effect immediately upon its adoption.




